# 1. Northshore MOMS Line – Offering Support, Resources and Crisis Intervention to Perinatal Patients and Providers in Illinois

The MOMS Line (866-364-MOMS) is a resource staffed by licensed mental health professionals 24 hours a day, 7 days a week equipped to provide crisis intervention, support, psychoeducation and referrals to perinatal women and those who care for them. This presentation will describe the 11,000+ calls received and critical success factors and lessons learned.
