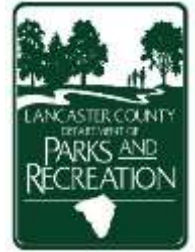




Jump In!

Do you like exploring creeks, wetlands, or rivers? Do you like hiking, canoeing, and discovering wildlife in an outdoor environment? Do you like drawing, painting and writing about what you see in nature? If so, this is the summer enrichment camp is for you! During the hot, muggy days of August, come spend a few refreshing days with Lancaster County Park naturalist, Lisa J. Sanchez; Nature Journalist, Carol Welsh; and IU13 Coordinator of Gifted and Enrichment Services, Janice Estabrook. Each day will be spent investigating and experiencing the science of water. By jumping in, you will see the connection between water and the living organisms on our planet. You can touch the critters living in the water, dissect plants, learn how to keep our water clean, and use paints and natural dyes to document discoveries. As a special treat, you will spend a day paddling in a canoe, learning water and canoe safety, and enjoying the wildlife while sitting in a canoe as it floats down the river. When summer temperatures rise, water offers fun, cool refreshment, and awesome opportunities for scientific discovery.

Each camper will go home with a nature journal with supplies and a personalized T-shirt and bandanna!

NOTE: If you have attended this camp before, join us again! Some of the activities and experiences differ from year to year -- and they are fun to repeat if you have done them before. New friendships await and you can enjoy favorite activities again while looking forward to new ones!
