- Frequent reports to parent on their children's progress, at minimum, six weeks into each trimester (deficiency/progress report notices). All parents are encouraged to activate ParentVue to monitor student's current grades.
- Reasonable access to staff, and opportunities to volunteer and participate in their child's class, and observation of class activities. Teachers must be provided 24-hour notice if a visitation is requested.
- Ensuring regular two-way communication between family members and school staff, and, to the extent practicable, in a language that family members can understand. Please contact the classroom teacher or office personnel if translation is needed.

Responsibilities of the Parents:

The Parents/Guardians agree to the following responsibilities to increase their student's academic success:

- Monitor attendance
- Activate ParentVue account
- Ensure contact information, including email, are up to date in the school office.
- Make sure homework is completed
- Become a volunteer partner with the school, when possible
- Participate in decisions relating to their children's education
- Stay informed about their child's education and communicate with the school by reading all notices from the school or the district and responding when requested
- Serve, when possible, on parent advisory groups such as the School Site Council, Parent Teacher Committee, English Language Advisory Committee, and district level committees.
