Culturally and Linguistically Appropriate Early Intervention Evaluations

Learning Outcomes:

1. Identify important factors to consider when making a differential diagnosis of speech and language impairments when assessing infants and toddlers (birth-36 months).
2. Identify a variety of assessment approaches and that can assist in the differential diagnosis analysis of infants and toddlers (birth-36 months) children and examine how to appropriately use those approaches with children from certain backgrounds.
3. Demonstrate knowledge of ASHA practice portals and evidence-based practice concerning Early Intervention evaluations.
4. Demonstrate knowledge of ASHA practice portals and evidence-based practice concerning the assessment of children from culturally and linguistically diverse populations.

Course Description:

In this course clinicians learn the components of a quality Early Intervention evaluation considering current law/regulations, informed clinical opinion, and evidence-based practice. Topics include the misuse of standardized tests, the importance of parents, when a bilingual evaluation is necessary, and how to identify Childhood Apraxia of Speech, all through a video case study model.
