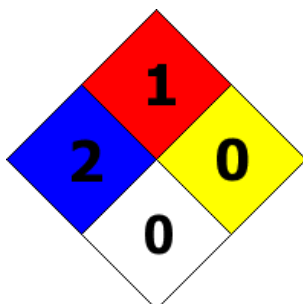

Suitable extinguishing agents:

SECTION 6: Accidental release measures
