PARTICIPANT RELEASE OF LIABILITY — READ BEFORE SIGNING

In consideration for the undersigned being permitted to participate in the ride and drive commencement ceremony at Michigan International Speedway on May 16, 2021 (the "Event"), the undersigned hereby forever releases, waives, and discharges Michigan International Speedway, LLC ("Track"), its parents, subsidiaries, and affiliated companies, their respective shareholders, officers, directors, employees, agents and Event participants (collectively, the "Released Parties") from any and all liability, for any and all loss of damages, and any claim or demand on account of injury, death, or damages to property whether caused by the negligence of the Released Parties, or otherwise. The undersigned knowingly and freely assumes all risks referred to above, both known and unknown, even if arising from the negligence of the Released Parties, and assumes full responsibility for risks arising from participation in the event.

Further, the undersigned shall indemnify, defend, and hold harmless the Released Parties from and against any and all liability, loss, damage, reasonable expenses, court costs and reasonable attorneys' fees in connection with, arising out of or directly or indirectly related to (i) any claim of loss or damage to property or of death or injury to persons, resulting from the Event; (ii) any claim of damage resulting from the acts or omissions of the undersigned, or (iii) any claim of damage resulting from the undersigned's breach of this Agreement.

For your safety and the safety of others, Track requires you to comply with the rules set forth below.

1. Vehicles to maintain safe speeds and appropriate distancing, as directed by Track, School staff and law enforcement staff.
2. Participants that do not abide by Track rules and regulations will be removed from the racetrack surface and property.
3. Participants/Vehicles observed dropping back or lagging behind and exceeding the paced speed will be removed from the racetrack surface and property.
4. No Passing Allowed.
5. No vehicles allowed on the banking of the racetrack in Turns 1, 2, 3, 4 nor the banked stretch before and after the start/finish line. Cars should remain on the apron, below the double-yellow line while in procession.
6. Participants or Vehicles determined by Track staff as unsafe or unfit will not be allowed onto the racetrack surface.
7. Passenger vehicles only (e.g. cars, vans, pickup trucks). No motorcycles, recreational vehicles, tractor trailers, buses, limos, 15-passenger vans etc., allowed on racetrack.
8. All passengers must ride in the cab of pickup trucks; no riders in pickup beds.
9. Participants must remain in vehicle at all times once they enter the facility, during the ceremony and while driving on apron.

The Participant(s) signifies by his/her signature below that he/she has read and understands the foregoing provisions and understands their participation in this activity is wholly voluntary and is not required for any school curriculum or graduation.
