## University Complete Withdrawal Policy

Adjustments to charges for complete withdrawal will be effective on the date written notice is received by the appropriate program office of Widener University. At that point the total withdrawal policy and refunding of semester charges is enacted. Students have a drop/add period at the start of each semester to adjust their schedule of courses. Once drop/add ends, semester course schedules are set and there is no refund issued when a student does a course withdrawal ( a “W” is noted on the student transcript) from one or more courses throughout the semester unless the student is withdrawing from all courses in the semester.

Students withdrawing from all classes at the Delaware Law Center of Widener University will be subject to the following refund schedule for tuition and fees:

### Delaware Refund Schedules Law Graduate Students:

<b>Summer SU1 and Summer SU2</b>	
100% Refund	If completed by the last day of drop/add
50% Refund	If completed by calendar day 15
0% Refund	No refund after calendar day 15

<b>Fall and Spring Semester (JD, MJ, LLM, SJD)</b>	
100% Refund	If completed by the last day of drop/add
90% Refund	If completed by calendar day 19
80% Refund	If completed by calendar day 31
70% Refund	If completed by calendar day 43
60% Refund	If completed by calendar day 55
50% Refund	If completed by calendar day 66
40% Refund	If completed by calendar day 76
0 % Refund	No refund after calendar day 76

<b>Legal Studies Courses – Fall and Spring Semester</b>	
100% Refund	If completed by the last day of drop/add
90% Refund	If completed by calendar day 19
75% Refund	If completed by calendar day 29
50% Refund	If completed by calendar day 40
25% Refund	If completed by calendar day 50
0% Refund	No refunds after calendar day 50

**\*The first day of the semester refers to the official start date of the semester. Please refer to the academic calendar for important semester dates.**

**Note:** If you completely withdraw from the University AND have received financial aid, you may be responsible for returning financial aid funds you have received based on the eligibility requirements set by the federal government. This may result in a balance owed to the University.

### University Refund Policy for Room

If you decide to do a complete withdrawal from the University or are approved to change from a resident to commuter or off campus student. Semester room charges are refunded based on the following tables:

Full Summer Semesters, Fall Semester and Spring Semester	
100% Refund	If completed by the last day of drop/add
90% Refund	If completed by calendar day 19
80% Refund	If completed by calendar day 31
70% Refund	If completed by calendar day 43
60% Refund	If completed by calendar day 55
50% Refund	If completed by calendar day 66
40% Refund	If completed by calendar day 76
0 % Refund	No refund after calendar day 76

Summer SU1 and Summer SU2	
100% Refund	If completed by the last day of drop/add
50% Refund	If completed by calendar day 15
0% Refund	No refund after calendar day 15
