Korean Comparison Webquest Lesson Introduction

This webquest is useful for teachers to help student to understand the differences between N. and S. Korea. Specifically, it deals with the economic and political differences between the two Korea's. The lesson also uses visual and textual information to convey this information to your students. Another useful part of this lesson is it can be used to highlight the effect that the Cold War and the Korean War on the development of modern day Korea.
