

Update - Effective June 1, 2021:
face masks are not required to be
worn inside or outside at 4-H camp

Dear Families Interested in 4-H Summer Camping:

The past year brought us many difficulties and changes, including not being able to hold 4-H camps in person. Although we are not completely out of the woods yet, things are looking much more promising than they were in the past. We are happy to say we are able to host a modified version of our typical camps. The 2021 Ohio 4-H Camping Guidelines were developed based on American Camp Association (ACA) research and the Responsible Restart Ohio Residential Camp plan. Our Washington County camping plan will also be under the direction of the Washington County Health Department. Due to these guidelines, we have decided to not offer overnight camps. Hervida is an amazing facility, but sadly the cabins are not very large. We would only be able to house around 30 campers overnight and that is not financially feasible.



As we sat down to brainstorm about the other possibilities, we wanted to give a few different options to allow everyone to make the best decision for their family. The schedule of camps is below. The single day camps are for those campers who want the typical camp experience but only a single day. The multi-day, Day camps will be a typical camp schedule with classes, tribes, recreation, swimming, campfire, etc. This would be 4 full days of Camp Hervida Fun!

Cloverbud Day camp Grades K-2: June 29th - Hervida (Lunch and Snack provided)

Single Day camp Grades 3-9: June 30th - Hervida (Lunch and Snack provided)

*Both of these camps will be single day. 9am-4pm)

Multi-day Day Camp Grades 3-9: July 5-8th - Hervida (Lunch, Dinner and Snack provided)

Multi-day Day Camp Grades 3-9: July 19-22nd - Hervida (Lunch, Dinner and Snack provided)

Drop off 9am, pick up 8pm Monday-Thursday Transportation available from Marietta to and from camp
Campers come every day Monday-Thursday

The camp July 19-22nd will only occur if there are over 50 campers interested in both weeks. If not, only the camp July 5-8th camp will occur.

Day camp Grades K-9: July 23rd - Washington County Fairgrounds (Lunch and Snack provided) 9:00 am to 4:00 pm

*This camp will offer different activities than the camps at Hervida.

We wanted to provide another option for those who couldn't travel to Hervida for day camps. This is why we are hosting the Day Camp at the Washington County Fairgrounds. We will have various activities available to the campers and we will also provide lunch and a snack to all campers.

A couple of things to remember. ~~Masks will be mandatory at all camps except when swimming or eating. One reusable mask will be provided to each camper and will be included with the registration fee (disposable masks will also be available).~~ We will also be following the guidelines for social distancing and number of people that are allowed in groups. The groups will be called cohorts and be given theme specific names. Your child may request one other camper that they would like in their cohort. This is on the form attached to this letter. We will be creating classes and activities that are not only safe, but also very fun and as close to a typical camp as possible. Due to our requirements of group size and the necessity for campers to stay within their groups as much as possible, all campers will take the same classes.



We know that these day camps can also bring up challenges with transportation. We are currently working with the local school districts to try and provide busing, leaving from Marietta in the morning and back to Marietta in the evening for the multi-day camps only. On the following registration page, if you would like this option, please mark beside the line that asks if transportation to and from Camp Hervida would be needed. There will be an additional, one time per camp, \$5 commitment fee for this transportation.

As mentioned above, the camp on July 5-8th will take place, however, the camp on July 19-22nd will only take place if we have at least 50 campers interested in both multi-day, day camps. This is to ensure that the cost for the camp is covered through camp fees. The cost of camp will include 2 meals and a snack everyday, a reusable mask, a camp picture, and supplies for classes. Campers may attend any and all camps that are age appropriate.

A Hervida Day Camp T-Shirt will also be available to purchase. This will be \$12 and the same design for every camp. Please mark that you would like a shirt on the form attached to this letter and what size you would like.

All camp fees must be paid no later than 30 days prior to camp:

May 28th for the June 29th and June 30th camps.

June 4th for the July 5-8th camps

June 18th for the July 19-22nd and July 23rd camps.

A 75% refund will be available up to 15 days prior to camp. (If a camper cannot attend due to exposure or COVID diagnosis, a full refund will be available up to the day of camp).

Once this registration is received, more specific information about the camp will be sent as well as additional forms that need completed such as the health form. If you drop off this form at the Extension Office, you may pick up these necessary forms there.
