# LETTER FROM CHAS DIRECTORSHIP

The Center for Health Administration Studies at The University of Chicago has been a leader for over 75 years in research and education in health policy and services. With its programs for supporting faculty research, engaging interdisciplinary inquiry, disseminating research, as well as promoting student learning, CHAS continues to explore new questions, identify knowledge gaps, and seek to enhance the translation of research to policy and practice focused on enhancing health care for the disadvantaged.

On March 23, 2010, President Obama signed the Patient Protection and Affordable Care Act (ACA) into law after at least 50 years of research and advocacy by a range of institutions and research centers, including CHAS. Perhaps the most significant health and welfare policy reform since the New Deal, the passage of the ACA has resulted in nearly 20 million uninsured individuals who have gained health insurance coverage. The work of CHAS continues to build on the rich tradition described so well in 1966 by health policy visionary and CHAS founder Odin W. Anderson. He described the basic value guiding health policy research in the United States: *That all people should have equal access to health services regardless of financial status.* This historic commitment to health equity can be found in all aspects of the work of CHAS.

Innovative health policy and services research was supported again this year through the CHAS Seed Grant Program. The 2015-16 program supported research on racial and gender disparities in suicidal behaviors in prisons, mental health services reform for undocumented Mexicans, racial disparities in predictive biomarkers, access to precision medicine, and cancer outcomes. This year, the CHAS-sponsored Michael Davis Lecture Series brought distinguished health policy and services researchers to the University. And finally, through partnerships and co-sponsorship, CHAS supported a series of important workshops and conferences including the CHAS-SciencesPo Workshop on Policy Innovation and Reform, the Big Data in Health Workshop, the Booth School's Healthcare Group's annual conference, and the Chronic Disease Center's Annual Research Symposium.

An intentionally interdisciplinary health policy and services research center located in a graduate school of social work is a unique institutional form that both exploits and enriches the values and orientation of the University of Chicago. We are proud that, in 2016, we engaged CHAS faculty and fellows along with health policy and services researchers from across the University of Chicago and around the world to engage in and advance innovative health policy and services research.

Building on its rich tradition, CHAS continues to support and advance research, disseminate knowledge and promote learning and teaching to promote quality health care for all.

# MEDICAID MAX WORKING GROUP



The CENTER FOR HEALTH ADMINISTRATION STUDIES recognizes that as Medicaid plays an increasingly central role in U.S. health care, it will be imperative to conduct national studies to analyze the costs and quality of care delivered to program enrollees and to understand large-scale changes in the prevalence of disease among the Medicaid population. The essential tools needed for these analyses and understanding are the volumes of patient data generated across the country in claims files called Medicaid Analytic eXtract (MAX) files.

Tamara Konetzka CHAS is supporting an interdisciplinary working group of faculty and Fellows to bring to the University of Chicago the most recent Centers for Medicare & Medicaid Services' MAX files for as many of the nation's 50 states as is currently available. The group will be among the first to use a national panel of MAX files to assess programwide performance and disease prevalence both at a single point in time and over several years. The working group's findings will allow state Medicaid programs and federal policymakers to understand how shifts in the external policy environment are impacting the care of Medicaid beneficiaries, and will additionally facilitate efforts to identify opportunities to improve the coordination of resources for the growing Medicaid population. Some long-term research goals include examining trends in the quality of care delivered to pediatric and adult Medicaid beneficiaries in the inpatient, outpatient, and long-term care settings, to examine trends in health care utilization and expenditures in the Medicaid program, and to examine trends in disease prevalence among Medicaid beneficiaries.



# May 26-27, 2016 The University of Chicago Center in Paris

The health and social service sectors in the U.S. and France represent large and dynamic sectors characterized by high levels of policy innovation and reform. Research and evaluation of health policy and health care reform is fundamental to democracy as well as necessary for the development of accessible, high quality and cost effective-services. In both US and France, research and evaluation has contributed to reforms in health and social service policy. However, the process by which social science research and evaluation can and does influence health policy innovation and reform is understudied and minimally understood. The focus of this University of Chicago-Science Po Workshop was to bring together on a regular basis health policy researchers and scholars from US and France to share recent and cutting edge work in a deliberately comparative and collaborative context.

# BIG DATA IN HEALTH WORKSHOP

# August 4, 2016 • University of Chicago Gleacher Center

The Center for Health Administration Studies (CHAS) partnered with the Computation Institute (CI) to co-host the Big Data in Health Workshop, a summer workshop event, with three goals: (1) to broaden the way we think about interdisciplinary collaboration necessary to advance data science at the University; (2) to build on ongoing data science projects; and (3) to stimulate new big data collaborations in health and health policy. As a health policy center, CHAS is well-positioned to coordinate the assembly of the University of Chicago's computational and behavioral and social science faculty to promote research and encourage collaborations between schools and departments. Select researchers and experts associated with various "big data" applications on campus, including cloud computing, informatics, EMRs, genomics, preventative analytics and evidence-based projects, were invited for a day of presentations and discussions to understand the state of big data on campus. Participants were eager to continue interdisciplinary events in the future and to use the workshop as a springboard to develop future conversations in analyzing health policy data.

CHAS actively pursues partnership and co-sponsorships with health policy researchers and centers interested in pursuing ambitious project in the CHAS areas of focus. Partnerships developed reflect the diversity significance of topics of concern to CHAS: health policy innovation and reform, health and social service integration, health access, cost and quality, behavioral health, global health and preventive intervention.


