COURSE DESCRIPTION: This lecture will introduce stochastic models used in Population Genomics to study the evolutionary forces that shape genetic variation. We will introduce these models in the neutral setting, and extend them to incorporate biological phenomena like natural selection, recombination, and changes in population size and structure. We will learn how to use these models for simulation, as well as applying them to modern genomic datasets to learn about the underlying evolutionary processes.

COURSE OBJECTIVES:

- Learn theoretical foundations of stochastic models used in population genomics.
- Implement these models for simulation and analysis of genetic data.

PRESENTATION:

As part of the final grade, students are expected to give a short presentation in class about a specific application of the different methods and models that we will discuss in class. In addition, a three-page summary of the chosen topic should be handed in. The instructor will provide a list of potential applications, but students are welcome to suggest their own topics. The instructor will supply or help in acquiring the necessary materials to prepare for the presentation. Depending on class size, the presentations might be prepared and given in groups. All presentations will be given on the last day of class (December 14).
